**PREVENT DISCONNECT**

**PRICE INCREASE**

Effective October 3, 2013, the month-to-month price of Business Local Calling (BLC) Unlimited A, Unlimited B, Block of Time and Measured packages will increase. BLC Unlimited A will increase from \$46.20 to \$51.00, BLC Unlimited B will increase from \$40.70 to \$45.00, BLC Block of Time will increase from \$39.60 to \$44.00 and BLC Measured will increase from \$36.30 to \$40.00. Customers currently on a BLC term plan will continue to receive their current BLC term package price. Customers currently on month-to-month pricing may disconnect their service without penalty.
